

**TOWNSHIP OF PITTSGROVE**

**ORDINANCE 09-\_\_\_\_**

**AN ORDINANCE AMENDING §83-20 and CHAPTER A120-1 OF THE CODE OF THE TOWNSHIP OF PITTSGROVE**

**WHEREAS**, §83-20 of the Code of the Township of Pittsgrove states, “Residents shall pay the appropriate disposal fee at the Public Works office prior to delivering the items to the waste disposal facility”; and

**WHEREAS**, current practice is that the disposal fees are to be paid to the Township Attendant at the waste disposal facility and not at the Public Works Office; and

**WHEREAS**, §83-20 must be amended to reflect this current practice; and

**WHEREAS**, Chapter 120-1 of the Code of the Township of Pittsgrove must also be amended to include the schedule of fees to be charged for disposal of items at the waste disposal facility; and

**WHEREAS**, the Township Code does not currently contain a fee schedule for these items.

**NOW THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Pittsgrove as follows:

- 1.** The third sentence of §83-20 of the Code of the Township of Pittsgrove shall be amended to state, “Residents shall pay the appropriate disposal fee to the Township Attendant stationed at the waste disposal facility prior to delivering the items to the waste disposal facility; and
- 2.** Chapter 120-1 of the Code of the Township of Pittsgrove shall be amended to include a section for fees charged under “Ch. 80, Solid Waste” and those fees shall be as follows:

<b>Permitted Waste Types</b>	<b>Fee</b>
White Goods: Refrigerators, Freezers, Air Conditioners	\$5.50 Each
Stoves, Washers, Dryers	\$5.50 Each
TV's	No Charge
Auto Tires up to 16” (Without rims)	No Charge
Truck Tires 17” & over (Without rims)	\$2.00 Each
Industrial Tires	\$7.00 Each
Auto Tires up to 16” (With rims)	\$26.00 Each
Truck Tires 17” & over (With rims)	\$3.00 Each
Computer Monitors	\$10.00 Each
	\$6.00 Each

Propane Tank – Large (over 20lbs)	\$21.00 Each
Propane Tank – Regular (20lbs ONLY)	\$5.00 Each
Propane Tank – Small (under 20lbs)	\$2.00 Each
*Pick Up Truck Demo of Debris	\$00.00 Per Load

**THIS ORDINANCE** shall take effect according to law. All other ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.
