**ORDINANCE**

**Of The Township Of Pittsgrove**  
**In The County Of Salem, State Of New Jersey**

**An Ordinance Providing For The 2009 Salaries  
And Compensation Of The Officers And Employees Of  
The Township Of Pittsgrove, County of Salem, State Of New Jersey**

**BE IT ORDAINED** by the Township Committee of the Township of Pittsgrove, County of Salem, State of New Jersey:

1. The following salaries, salary ranges and hourly rates are hereby fixed for the officers and employees of the Township of Pittsgrove for the year 2009:

2. The salaries and compensation fixed in the foregoing section of this ordinance are payable bi-weekly on Fridays or monthly depending on the employment position in accordance with the Wage and Hour laws of the Federal and State Departments of Labor and the Pittsgrove Township Personnel Policy Manual.
3. Calculation of overtime for hourly rate employees shall be based on an hour for hour basis for any work up to and including forty (40) hours. All hours in excess of forty (40) hours per week shall be calculated at one and one half times the stated rate.
4. The Tax Search Officer and Municipal Search Officer shall receive compensation for searches completed and fees received, payable quarterly, in the amount equal to the fees collected each quarter.
5. The Tax Assessor shall receive compensation for property lists completed at a fee of \$10.00 per list, payable quarterly.
6. All ordinances, or parts of ordinances inconsistent with the provisions of this ordinance are hereby repealed.
7. Should any part of this ordinance be declared invalid, such part shall not invalidate the remaining portions of this ordinance.
8. This ordinance shall take effect as permitted by law, effective/retroactive January 1, 2009.
